LRE Lawyer of the Year

The SC Bar Law Related Education (LRE) Division is accepting nominations and self nominations for the LRE Lawyer of the Year Award. The LRE Lawyer of the Year award will be presented to a member of the South Carolina Bar who has

- Fostered public understanding of the values of our legal and judicial system;
- Stimulated a deeper sense of individual responsibility by helping students recognize their legal duties and rights;
- Encouraged and supported effective LRE programs; or
- Increased communication among students, educators, and those working in the legal system.

The LRE Division also considers the length of time over which a nominee has worked to promote education about the profession and gives additional weight to nominees with a history of supporting its mission. Some examples of activities that would support a nomination are volunteering to judge or coach Mock Trial programs and *We the People* programs, speaking to school classes, and participating in conflict resolution, Youth Court and peer mediation programs. The LRE Division, however, recognizes that nominees may contribute through a variety of formal and informal activities.

The SC Bar appreciates the contributions of lawyers that support law related education. The lawyer chosen to receive the LRE Lawyer of the Year award will receive a plaque in front of their peers at the annual House of Delegates meeting in May.

Nomination Procedure:

1. Complete the nomination cover sheet.
2. Include a nomination letter in no more than three (3) pages, typed, double-spaced 12 point font, and one inch margins. Nominations are limited to five (5) pages of pictures that are imported into the document (physical pictures adhered on paper or photo books are not permitted).
3. Include a resume of the nominee.
4. Attach up to five (5) letters of support. Letters written within the last 24 months will be considered.
5. Return one (1) original, hole punched nomination packet. **Packets must be postmarked to the SC Bar LRE Division no later than March 19, 2014.**
6. Previous winners will not be considered for three (3) consecutive years.
