LRE We the People Scholarship
\$500 Award

To recognize achievement and the impact that the *We the People* programs have on the lives of the students who participate, the South Carolina Bar Law Related Education (LRE) Division has created a scholarship program for *We the People: The Citizen and the Constitution* and *We the People: Project Citizen* participants. The selected recipients of the \$500 *We the People* scholarships must have participated in either *We the People* program at an in-school competition, district competition, state competition and/or national competition to qualify for the scholarship.

Eligibility Requirements for Applicants:

1. Must be a high school senior;
2. Must be or have been a student that participated in a *We the People* class that participated in a competition sponsored by the SC Bar LRE Division;
3. Must have a minimum GPA of 2.5; and
4. Must plan to attend a post-secondary institution such as a technical, 2-year or 4-year college/university.

Evaluation/Award Process:

1. Members of the LRE Awards Committee will evaluate the applications.
2. The LRE Division will notify recipients by May 1, 2008.
3. Awards will be disbursed to recipients upon receipt of a letter from the Registrar of the institution indicating that the recipient is enrolled as a student.

Application Procedure:

1. Complete the application cover sheet.
2. Explain what the *We the People* program(s) meant to you in no more than three (3) pages, typed and double spaced. Make sure to indicate which *We the People* program that you participated in.
3. Attach two (2) letters of recommendation, at least one of which must come from your *We the People* teacher.
4. Return one (1) original of the entire nomination packet. **Packets must be postmarked to the SC Bar LRE Division no later than March 20, 2008.**
5. Please do not put any pages in plastic protector sheets.
