Olivia Jones

Olivia Stafford Jones is a native of Columbia, South Carolina. She graduated from the South Carolina Honors College in 2001 with a B.A. in Spanish. After graduation, Olivia lived in Chile for a year on a Rotary Ambassadorial Scholarship, where she obtained an Associate's Degree in Public Administration in 2002 from the Pontifical Catholic University of Chile in Valparaiso and became fluent in Spanish. Olivia graduated from the University of South Carolina School of Law in 2007, having served as president of the Pro Bono Program.

Licensed to practice law in South Carolina and in federal court, her legal career has included roles as a staff attorney at the SC Administrative Law Court and South Carolina Legal Services, as well as an associate at a nonprofit immigration law firm. From 2015 to 2023, she ran her own solo practice, focusing on family law, immigration, and probate matters. In 2023, Olivia began serving as the Executive Director for the South Carolina Bar Foundation.

Olivia has served on the South Carolina Access to Justice Commission since 2021 and is a longtime member (and past chair) of the Richland County Bar's Public Service Committee. She is also a past president of the Rotary Club of Five Points in Columbia, where she has been a member since 2009. Olivia co-founded and volunteers at the Richland County Divorce Help Desk, which connects volunteer attorneys with people navigating divorce on their own. Olivia is a member of the Richland, Greenville, and Charleston County Bars, as well as the S.C. Women Lawyers' Association.

In 2020, Olivia was honored to be named the S.C. Bar's Pro Bono Attorney of the Year, and in 2024 she was presented with the Civic Star Award by the Richland County Bar Association.

Kharimah Roacher Desso graduated from the University of South Carolina School of Law with a concentration in Children's Law. Upon admission to the South Carolina Bar, she began her legal career at the South Carolina Legal Services Corporation, representing indigent citizens in housing disputes, access to education and special education hearings, consumer debt and abuse cases, denial of public benefits appeals, wills, trusts, estates, and family law matters.

She later joined the Brunson Law Firm, LLC in Sumter, South Carolina as a general practitioner. Kharimah also served as an Assistant Prosecutor for the Fifth Judicial Circuit, prosecuting domestic violence crimes, and as Staff Attorney for the South Carolina Coalition Against Domestic Violence and Sexual Assault (SCCADVASA), where she provided legal technical assistance and support to attorneys and legal professionals throughout the state. In this role, she responded to calls from survivors of domestic and sexual violence, providing legal information and referrals to SCCADVASA's 22 Member Organizations, legal services partners, and pro bono/low bono attorneys.

She has served on the South Carolina Bar's Voices Against Violence Committee and is a former board member of The Hive, a survivor-driven, culturally specific peer advocacy organization dedicated to helping women and girls in South Carolina overcome the trauma of sexual assault, intimate partner violence, and stalking.

In recognition of her service to survivors, Kharimah was awarded the 2019 Judiciary Award by the YWCA of the Upper Lowlands.

In 2018, Kharimah founded The Paraclete Law Center, LLC, a boutique law firm focusing on family law, probate, and personal injury. She is a VA Accredited attorney, authorized to assist claimants in pursuit of benefits before the Department of Veterans Affairs. She also serves as a Guardian Ad Litem in highly contested domestic matters. Her firm's goal is to help families navigate and prevent crises so they can move forward with confidence.

Outside of her professional life, Kharimah is a mother of three and enjoys cooking, thrifting, and traveling to state and national parks.

Prior to joining SCCADVASA, Tricia served as the Director and Attorney of the SC Victim Assistance Network's (SCVAN) Immigrant Victim Program, where she established the organization's specialized legal and supportive services to immigrant survivors of crime and the SC Immigrant Victim Coalition, which brings together professionals throughout the state working with immigrant survivors of domestic violence, sexual assault, child abuse and human trafficking.
