Adam Neil

Managing Counsel for Litigation, S.C. Department of Revenue Columbia, SC

Adam Neil became the Managing Counsel for Litigation at the South Carolina Department of Revenue in January 2019. In addition to litigating both tax and regulatory matters for the SCDOR, Adam provides oversight of all aspects of civil, criminal, and administrative litigation to the Department's Office of General Counsel for Litigation. Adam spent sixteen years in private practice with Murphy & Grantland, P.A. before entering public service. In addition to his work with the SCDOR, Adam has served as Assistant General Counsel for the South Carolina State Fiscal Accountability Authority. He has tried over forty cases to verdict and has handled matters in the state Court of Appeals and Supreme Court as well as the Fourth Circuit Court of Appeals.

A native of Frankfort, Kentucky, Adam obtained his Bachelor of Science degree in Economics and Finance from the University of Kentucky, *magna cum laude*. He went on to law school at Washington & Lee University in Lexington, Virginia where he was the Judge S. Leslie Mestrezat scholar and a member of the moot court board.

The Honorable Florence P. Belser

Florence P. Belser is a Commissioner on the Public Service Commission of South Carolina representing the 2nd Congressional District. Ms. Belser attended the College of Charleston, where she received a Bachelor's Degree in Biology, and she earned her Juris Doctor at the
