2024 LRE Lawyer of the Year

The SC Bar Law Related Education (LRE) Division is accepting nominations and self nominations for the LRE Lawyer of the Year Award. The LRE Lawyer of the Year award will be presented to a member of the South Carolina Bar who has

- Encouraged and supported effective LRE programs;
- Fostered public understanding of the values of our legal and judicial system;
- Stimulated a deeper sense of individual responsibility by helping students recognize their legal duties and rights; and
- Increased communication among students, educators, and those working in the legal system.

The LRE Division also considers the length of time over which a nominee has worked to promote education about the profession and gives additional weight to nominees with a history of supporting its mission. Some examples of activities that would support a nomination are volunteering to judge or coach Mock Trial programs and *We the People* programs, and speaking to school classes.

The SC Bar appreciates the contributions of lawyers that support the Law Related Education Division. The lawyer chosen to receive the LRE Lawyer of the Year award receives a plaque in front of his/her peers at the annual House of Delegates meeting in May.

Nomination / Application Procedure:

1. Complete the nomination/application cover sheet.
2. Include a narrative of the applicant/nominated teacher to reflect the format requirement below.
3. Include a resume of the nominee.
4. Submit up to five letters of support. Letters written within the last 24 months are considered.
5. Scan the entire application packet (cover sheet, narrative, resume of the applicant, and up to five letters of support), as one PDF document and include your name when naming the PDF document; e.g. Landrum Logan Lawyer App 2024.
6. Email the PDF to Donald N. Lanier at dlanier@scbar.org by 12 noon on March 20, 2024. (Only emailed submissions will be considered.)
7. Previous winners are not considered for three (3) consecutive years.
8. The LRE Division will notify recipient by May 2024.

Format Requirement:

Include a typed (12 point font) narrative not to exceed three pages, typed and double-spaced. No more than five additional pages of pictures may be added to the document. If the format requirement is not met, the nomination/application will not be considered.
