She transitioned to Acting Head of Building Family Bridges in January 2023 when Dr. Rand went on sabbatical. In September 2024, she became the Founder of that agency, now called Family Bridges Institute, based out of Toronto, Canada. Dr. Parnell developed the Family Bridges Aftercare Protocol for alienating parents, now the standardized protocol used in all Family Bridges cases.

She also trains professionals from around the world wishing to learn the Family Bridges methodology and presents at conferences on severe alienation and Family Bridges. She conducts outcome research on her work with Family Bridges cases.

Dr. Parnell has published in the fields of neuropsychology and psychoanalysis. She has two manuscripts related to her work in preparation for publication: Family Bridges: 18 Years of Data (with Amanda Sharples) and An autoethnographic analysis of 'waking up' from the horror of international parental child abduction and severe parental alienation: the lived experience of a young girl and her mother (with Hannah Flowerday).

We are excited Dr. Parnell agreed to join us at the 2026 South Carolina Bar Convention and offer her incredible insight into and experience with the cases that so often leave practitioners, courts, parties, and children feeling torn, if not frustrated, from the start.
